Membership Application Guidelines & Policies

- Waiver:REQUIRED
- Proposer/Seconder: Required
- Membership Card: Temporary card is issued after paying the membership fee
- Stock Certificate: Issuance is from two (2) to three (3) months
- Earliest Time to Play: Upon issuance of temporary card
- Corporate assignees:
 - 2 corporate assignees and should be a member of the Board or executive of the company
 - Dependents' age limit: up to 24 years old; unmarried
 - Guests should be accompanied by a member
 - In-active share cannot be leased out; the shareholder has to activate it first and has to pay the membership fee.
 - The membership fee of an existing member is waived if he/she will change status but it should be done within 60 days only.
 - The Club is open from Tuesdays to Sundays only.
